MINING LICENSES/FEES

Mining Application Fee: Fee will be \$300.00 for mining parcels up to 40 acres, and \$5.00 for each additional acre.

Inspection Fee: Fee shall be actual fee for a licensed Engineer or Surveyor to determine if what the mining operator says they have for topsoil reclamation is accurate, and to determine how many cubic yards of soil will be required for reclamation of the site to be used in determining the escrow fee.

Escrow Fee: Cost of the escrow fee is determined by the estimated cost to reclaim the property with 4" of topsoil based on \$10.00 per cubic yard, less the amount of top soil currently stock piled for reclamation purposes, and the cost to install and grade to meet ordinance requirements.
