

**EUREKA CHARTER TOWNSHIP SPECIAL MEETING MINUTES**  
**MONDAY, JULY 24, 2014**  
**Approved**

Supervisor Rodney Roy, at the Eureka Township Hall, 9322 S. Greenville Road, Greenville, MI, called the Special Meeting of the Eureka Charter Township Board to order on July 24, 2014, at 7:00 pm. After the Pledge of Allegiance, Clerk Ruwersma stated that the following Board Members were present: Supervisor Rodney Roy, Clerk Linda Ruwersma, and Trustees Marty Posekany and Brad Kelley. Treasurer Cindy Hanson and Trustees Jeremy Austin and Elaine Pendrick were absent. These minutes will not be approved until the August 11, 2014 Regular Board Meeting. Only one other person, Linda Weger, was in attendance.

Purpose of the Special Meeting is to interview candidates and hire a new zoning official for the open position in the Eureka Charter Township Zoning Department.

Supervisor Roy explained to the Board and the audience that Mr. Tom Faussett recently resigned from his position as Zoning Official of Eureka Charter Township. Three resumes came in from William Mark Wilkin, Heather Lange, and Robert Mulholland. Because the only candidate present for an interview at the Regular July 14, 2014 Meeting was Robert Mulholland, this special meeting to interview more candidates was suggested, and the interview at the regular meeting did not take place that night.

Supervisor Roy stated that there will be no Public Comment during this meeting and that audience members are only at the meeting to observe and must be silent during the interviews. He also asked the candidates if they would like to stay during the other person's interview or leave, and neither objected to have the other stay.

Trustee Kelley moved, with a second by Trustee Posekany to officially accept the resignation of Mr. Tom Faussett, Eureka Charter Township Zoning Official, as of July 1, 2014. Ayes: 4, Posekany, Kelley, Ruwersma, and Roy. Nays: 0. Motion carried.

Those present for interviews were William Mark Wilkin and Robert Mulholland. The third candidate, Heather Lange, did not show up. After approximately 55 minutes of interviewing the two candidates, Trustee Posekany moved, with a second by Trustee Kelley to hire William Mark Wilkin to be the new Eureka Charter Township Zoning Official, active immediately. After training is finished, office hours at the hall will be Monday through Friday, 9:00 am to 1:00 pm, with the salary being negotiated at a later date. Ayes: 3, Posekany, Kelley, and Roy. Nays: 1, Ruwersma. Motion carried.

Supervisor Roy adjourned the meeting at approximately 8:12 pm.
